Whereas the draft of the following Rules further to amend the Karnataka Civil Services (Service and Kannada Language Examinations) Rules, 1974, was published as required by clause (a) of sub-section (2) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), in Notification No.DPAR 13 SSR 2003, dated 17th January, 2004 in Part IV-A (No.43) of the Karnataka Gazette Extra-ordinary dated 17th January, 2004 inviting objections and suggestions from persons likely to be affected thereby within fifteen days from the date of publication of draft in the Official Gazette.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby make the following Rules namely:-

RULES

1. **Title and commencement.**- (1) These rules may be called the Karnataka Civil Services (Service and Kannada Language Examinations) (Second Amendment) Rules, 2004.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. **Amendment of Schedule-II.**- In Schedule II to the Karnataka Civil Services (Service and Kannada Language Examinations) Rules, 1974, in the Table, in the entries relating to the Karnataka General Service Department of Scheduled Caste and Scheduled Tribes, after the entries relating to the category of post "District Social Welfare Officer" at serial number 21, in columns 2 and 3, the following Category of post and entries relating thereto shall be inserted, namely:-
