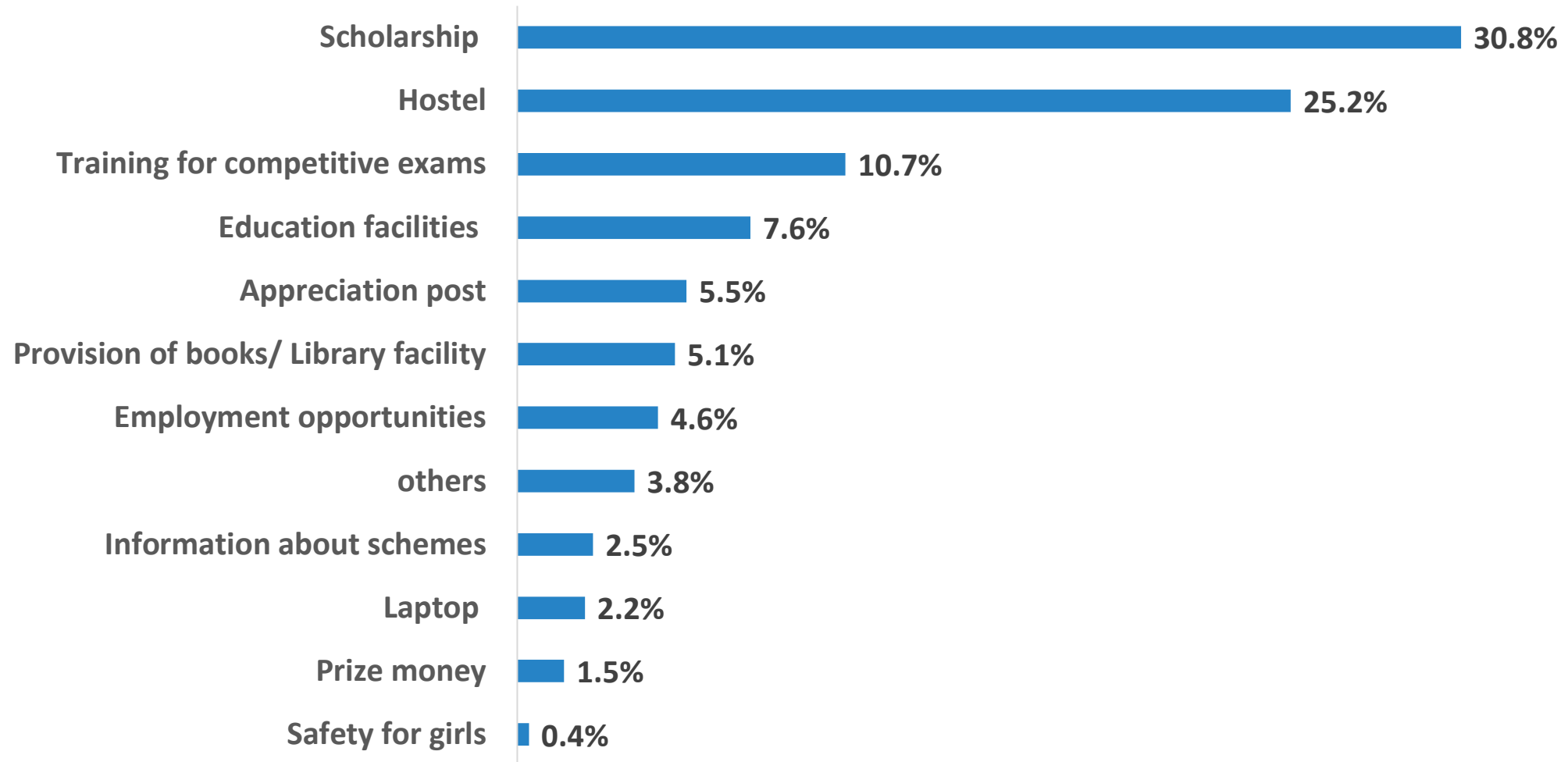

Students also suggested innovative ideas like waste segregation in hostels, kitchen garden etc.

Provision of books for students from rural areas (apart from facility in the hostel) was also witnessed a high number of entries



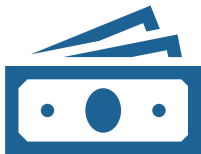
Students also enquired about job opportunities after graduation, specifically students who have graduated with a B.A degree.

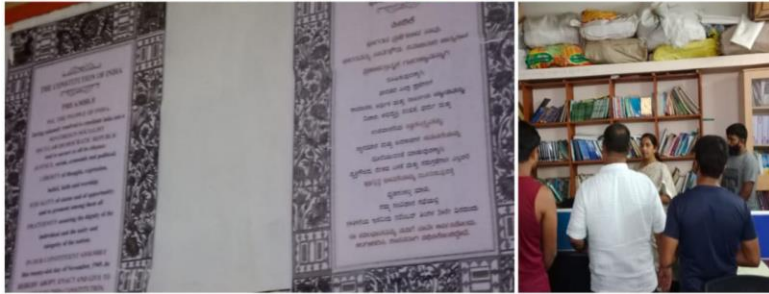
